Chair's Report 2022

Dear members,

I am happy to convey, taking several measures into account, that 2022 should be recorded as a successful year basketball in Tasmania. Pleasingly, it saw us really and truly back on courts across the state (post the interrupted



COVID years), and we also recorded significant growth in many areas.

From all BTAS Board members I want to extend my thanks to everyone who has contributed by adding value to basketball in Tasmania – and gratefully, there are many of you with success prevalent on several spheres. Whilst overall the number of our volunteers is decreasing, they continue to be our lifeblood.

The ability to switch from managing imposed restrictions to growth is impressive, however, as we know this doesn't come without collective effort and purposeful activity, nor does it come without its challenge, as is articulated more clearly in our CEOs report, enclosed within.

Our sport is expanding, and this has placed increased strain on our resources. In 2022 we invested in areas to support growth and encountered increased operational costs in a number of areas. Fortunately, a solid financial base allowed for this investment, however moving forward it is important that our decisions and choices see us operating within our means. We are acutely aware of our financial responsibilities and the need to ensure financial sustainability moving forward.

That aside, there were many positives - a wave of renewed interest, with increases in the number of children and young people engaged in basketball (rosters, camps, junior pathway programs); sustained involvement at senior and masters' level; with the game also continuing to increase its capture the supporter/spectator market in the state (and further afar, with loyal expats never forgetting their roots!)

Well done JackJumpers, undoubtedly the success of your most recent season, and the excitement and culture you continue to build has contributed to the surge of interest. Of course, having NBL in our state has also resulted in growth and development in other areas - officiating (a big shoutout to referees, score table, statisticians and coaches who can now participate at this elite level on our own turf), also in sports administration and leadership.

Recognition also to Tasmania's NBL1 clubs, Launceston Tornadoes, NW Thunder and Hobart Chargers for their commitment to participate in this league, presenting both a quality product and pathway opportunities for our athletes. Special mention to Hobart Chargers who were winners of the Men's 2022 NBL1 South Conference, earning themselves a place at the inaugural NBL1 National Finals.

Thanks also to our CAMs and clubs for what you do – we know that grass roots basketball; entry level programs; local, place-based competitions and programs, are the mainstay of our sport and we must continue to support and assist you in your work right across our state, but also, learn from you! BTAS is committed to supporting and working with our CAMs in their efforts to grow and develop basketball in their communities.

My appreciation also, of the governance and incisive guidance provided by our Commissions – also their time commitment.

Well done to BTAS Staff (and those who have assisted) on the strength of the work in coaching (including Basketball Development Officers) - for leading state development and high-performance programs and state teams; with the excellence of coaching not just reflected in the increased skills and abilities of our players and team success but also the capacity building, upskilling and accreditation of more coaches. Of course, Ben is ably supported by Kylie French whose influence and impact goes way beyond her role as Finance and Human Resource Manager. Appreciated!

To our players – great choice of a sport! Whether your involvement is as a 5-year-old in Aussie Hoops (bright eyed and energy aplenty), playing local roster, competing in a state league, or regional competition, attending clinics, aspiring to state or Australian selection, or even forming a pick-up team for a 3x3 game – there are so many benefits to be achieved from this great game. Relish your time on court training or playing as part of a team, be proud of the physical and skill development you achieve (through effort) – and never forget the fun and enjoyment the game brings. We are always keen to hear from our players regarding player experience. Whilst some things are beyond our control, be assured we are eager to capture feedback as we work together for continued growth of our sport.

Of course, this invitation for feedback is extended to all. I have also heard that we must be very mindful of the current pressures on families and our economy – and ensure that accessibility to the sport is prioritised. Also, the importance of ensuring viability and sustainability of our CAMs and clubs. Not to mention, referee development and retention, which continues to be a thorny issue. Please be assured your voices are always heard.

In closing, I do want to note the continued partnership and support of Basketball Australia; we are certainly very appreciative of their guidance and their commitment to providing up-to-date advice regarding governance principles, policies, by laws and key information. The world of sports administration continues to grow in complexity!

Thank you to my fellow BTAS Board members who bring great voice, agency, and perspective to our Board, also for their generosity of time and the strength of their commitment and responsibility. On a final note, I take this opportunity to thank the whole basketball community for their support and passion over the last year and I look forward to the exciting times ahead for our sport.

Chief Executive Officer's Report 2022

It would be fair to say that Basketball has been the talk of the Tasmanian and to some extents, Australian sporting landscape in 2022 with surging interest, demand, and engagement across the state. However, this growth in the game is not unique to Tasmania with the sport growing consistently across all states and territories.



This growth does not come without challenges and the strain being placed on existing staff, volunteer workloads and facilities is immense, and the sport finds itself in desperate need of further resources to service and support this surging demand. Financially, we have not been immune to increased costs, and this combined with increased investment in the game sees us record a significant operating deficit at year's end. We will need the support of our CAMs and all Basketball stakeholders to ensure our underlying business model is sound and can sustain ongoing and further investment in the game into the future.

Community sport lives and breathes due to the outstanding contributions of thousands of volunteer's week in and week out. Whether that is coaching, refereeing, organising uniforms or social functions, serving on boards, commissions, and committees, running canteens, or working on the score bench. Grassroots sport cannot operate without all of these volunteers, and we need to make sure all of Basketball's collective energy is directed towards supporting their work.



Overall participation in Basketball has grown in the last two years, but for every ten new players entering the game, we need a new coach, referee and score bench, access to a court and competition support to ensure their experience is the best it can possibly be.

Whilst outstanding and a credit to all involved, if we take a broader perspective:

- On a per capita basis 2.06% of Tasmanians participate in Basketball, which is 1% behind the participation rate for Australia's leading Basketball state – Victoria and ranks Tasmania 5th highest in the country for basketball participation per capita.
- For Tasmania to match the Victorian participation a further 5,353 Tasmanians would need to participate in Basketball.
- To accommodate this growth a further 26 "NEW" courts on top of existing infrastructure are required
 and this would only allow each team to access a court for 1 hour per week.

Once again there were many highlights for our sport during 2022:

- The completion of an audit of facilities across Tasmania forming the foundation for ongoing lobbying efforts to increase the quantity, quality, and accessibility of basketball venues state-wide.
- The delivery of a Referee Development Strategy which resulted in 214 new referee's gaining accreditation and 37 referees progressing from Green Shirt to Level 1 accreditation along with 26 referee coaches completing courses.
- Delivery of 33 coach development programs for over 400 coaches including the ongoing Coach Acceleration Initiative.

- Continued development of our junior pathway programs from FDP, SDP, Tri-Series competition, and pathway through to representing Tasmania and beyond.
- Selection of 5 Tasmanian athletes and 1 coach to represent Australia in various FIBA competitions
- First time ever that all teams in National Championships from U16 upwards have finished in the top eight, highlighted by the Men's U18's Bronze medal in Ballarat, and the Ivor Burge team's Bronze medal in Mackay.
- The roller coaster not-quite fairytale ride for the Tasmanian JackJumpers in their first season culminating in a dramatic Grand Final appearance and the engagement with their journey across Tasmania and Australia.
- The completion and opening of two new courts at Pembroke Park in Sorell.
- The Men's Hobart Chargers Championship winning

- run and the Launceston Tornadoes Women's team's finals appearance in the NBL1 competitions.
- Ongoing engagement of commissions in each region to strategically evaluate the best direction for basketball and provide insight to the BTAS Board.
- There are currently 8 Tasmanian Players, coaches and referees involved in the NBL and WNBL.
- Ongoing State Government commitment of \$1M over four years to continue school basketball clinics in conjunction with the NBL1 clubs.
- There are currently 11 x Tasmanian athletes with full college scholarships in the USA.

Once again, thank you to all involved in the sport as we strive to be the Sport of Choice for all Tasmanians.

Basketball Development Manager's Report

2022 was an extremely successful year for basketball in Tasmania.

The year started with BTAS sending 13 Teams to Adelaide, attending the Adelaide Invitational Tournament (in place of the Country Cup, which was cancelled due to



COVID-19). While the tournament had a different feel to it than the Country Cup, it still provided a great development opportunity for our players, coaches, staff, and referees. This experience set the tone for the year, with everyone involved displaying great adaptability and resilience when faced with challenges on and off the court.

Our development programs boast over 500 participants from U12s through to U18s, and they are well respected Nation-wide. February saw the start of a busy period for our development programs with weekly programming sessions, camps, and Tri-Series tournaments.

In amongst all of this, our State Teams completed their selection process and began ramping up their preparation for the 2022 National Championships. 2022 was our most consistent year from a results perspective, with every one of our State Teams finishing in the Top 8, the first time this has happened.



Final placings were Ivor Burge Men 3rd, U20 Men 8th, U20 Women 7th, U18 Men 3rd, U18 Women 8th, U16 Men 7th and U16 Women 7th.

While it was pleasing to have two Tasmanian teams claim a bronze medal at a National Championships, the highlight for me is always the way in which all our teams conduct themselves on and off the court. This is something we pride ourselves on and are nationally recognised for.

On top of team success, 2022 was a massive year filled with individual athlete and coach success.

- 8 Tasmanian Athletes (Charli Kay, Macey Crawford, Rubi Gray, Lachlan Brewer, Jacob Furphy, Kye Savage, Nash Walker & Jasper Hay) were selected for Australian Junior Squads.
- 4 Tasmanian Athletes (Rubi Gray, Lachlan Brewer, Jacob Furphy and Kye Savage) were selected to attend the U17 Asia & World Cup.
- 2 Tasmanian Athletes (Kye Savage and Lachlan Brewer) were selected to attend the NBA's Basketball Without Borders Camp in Canberra.
- 2 Tasmanian Athletes (Macey Crawford and Ava McDonald) were selected to attend the Inaugural Women's NBA Academy Games in Atlanta, USA.
- Nash Walker was selected as the Captain of the U15 Australian Men's Team which won Gold at the U15 FIBA Oceania Championships in Guam.



- Nic Martin was appointed as an Assistant Coach for the U15 Australian Women's Team which won Gold at the U15 FIBA Oceania Championships in Guam.
- The number of Tasmanian Athletes competing in the US College System grew further, with Emerson Wells, Seir Deans and Makala Bingley joining our already strong stocks in the US.
- Our representation at the WNBL and NBL level went to an all-time high, with Tasmanians Micah Simpson, Gabe Hadley and Hayden Zasadny joining the likes of Mark Radford, Tanner Krebbs and Lachlan Barker who are either coaching or playing at the professional level.

numerous athletes and coaches having travelled the world for Basketball in 2022.

These individual achievements highlight the opportunities that exist in our sport and how Basketball is very much a global sport, with From a coach development perspective, 2022 was another strong year in this space. We delivered 33 formal coach development programs (i.e., Coach Clinics, Coach Huddles and Courses) involving over 400 participants across the State - a 22% increase in activity and participants on the previous year.

Some of the 2022 Coach Development "highlights" included:

- Gala Weekend Coaches Clinic with Jack Fleming (Tasmania JackJumpers).
- High-Performance Coaches Clinic with Sarah Graham (BA Centre of Excellence).
- WNBL Coaches Clinic with Cheryl Chambers & Tracy York (Southside Flyers & Bendigo Spirit).
- Introduction of Coach Developers for State Teams which provided our coaches with additional mentoring and support from high level coaches.

While there is still plenty of work to do, Coach Development, State Programs and our Development Programs are in as strong of a position as they have ever been.

To all the network coaches, parents and volunteers who have played a role in developing our State and made 2022 successful, thank you! Your contribution is greatly appreciated.

General Manager (North West) Report

If anything proved that basketball in Tasmania was in the midst of a 'boom', it was the increase participation for our junior competitions throughout the region. Despite travel, costs, and conflicting schedules with other sports and activities in the region, we still saw a substantial increase in participation rates (coaches and players)



for our flagship TJBL Northern Conference competition in 2022. Some CAMs (Penguin, Launceston) trialled shifting Boys basketball to Saturdays to ease the court capacity issues we experience from this growth, with successful results. We saw a slight decrease in close margins for Championship divisions, but an increase in closer games for Shield division – following a manual grading process due to COVID.

We established the Player Points System (PPS) after the 2022 NWBU Season review ahead of the Season 2023, which should increase player retention and junior to senior pathways, and we delivered a successful community engagement project with WNBL sides Southside Flyers and Bendigo Spirit. Overall, 2022 was a busy and successful year for basketball in the North and North West, and we anticipate further growth and interest in the sport.



GOVERNANCE

North West Basketball Union Commission

The NWBU Commission continues to provide strategic and operational oversight to basketball activities on the North-West coast. The commission had a few personnel changes during the year with Darren Long and Sam Armstrong resigning from their posts, while we sadly lost Garry Gale when he passed away in July of 2022.

The commission has retained the core group of Josh Molendyk (Chair), Rebecca Triffett, Shane Hayward and Martin Parker (Referee delegate).

Across the 2022 calendar year, the team provided oversight and effort on some major events and projects, namely:

- TJBL Grading (completed manually in 2022)
- TJBL Competition
- NWBU Finals Series and Awards night
- NWBU Finals Referee Panel
- Introduction of Player Points System (PPS) for NWBU in 2023
- NWBU U10 & U22 competitions
- Guidance resolving many competition disputes across all formats of competition

Player Points System (PPS)

The NWBU Commission and BTAS introduced the concept of the PPS during the NWBU Season review in July/August. The concept was workshopped and then tabled at Presidents meetings in September/October to ensure complete stakeholder engagement. The first release was introduced in December 2022, with CAMs to comply with the system in Season 2023.

Launceston Classic Fast Fact.

A record number of 130 teams competed in 281 games across 5 venues over the weekend.

Feedback on the system has been positive with some of the following behaviors observed during recruiting phases:

- Increase in returning players, especially female
- Inclusion of U18 athletes into senior pathways
- Reduction of CAM-to-CAM transfer of local based players (from 2021)
- Introduction of more sub-NBL1 level talent from intrastate and interstate
- Increase in imports across both forms of competition

The system is designed to increase junior to senior pathways, heavily incentivise CAMs for their junior development, and constrain CAMs recruiting international talent over Australian and then Tasmanian talent. Further analysis is required; however, early indications are that the system is having a positive impact on the competition to date.

PARTICIPATION AND GROWTH

Representative Competitions

Participation numbers in 2022 saw an increase across the board with 2815 registered participant seasons (this includes coaches, and anyone who played multiple divisions), and includes:

- NWBU Men's and Women's divisions.
- NWBU U22s Men's and Women's divisions.
- TJBL U12, U14, U16, U18 Boys and Girls divisions.
- NWBU U10s Boys and Girls divisions.

The same number for comparative purposes, from 2021 was 1676 registered participant seasons.

This increase in volume can be attributed to:

- NWBU minimal to no increase.
- NWBU U22s slight 1% increase in registered players and coaches.
- TJBL significant 10% increase in registered players and coaches, increase in teams of 8%.
- NWBU U10s significant 20% increase in registered players and coaches, increase in teams of 25%.

TJBL Northern conference competition trialed different competition structures, game days/nights, formats to collect information about the best options to determine competition structure in 2023 and beyond.

Results – Championship Division

The margin results experienced in Championship Division throughout the 2022 TJBL Northern Conference Competition were very close and was a good reflection of participants competing against others of similar talent levels. 51.9% (-5.5% on 2021) of games were decided by less than 20 points, and 27.9% (-8.2% on 2021) of games being decided by 10 points or less.

Results - Shield Division

The margin results experienced in Shield Divisions throughout the 2022 TJBL Season were also very close given the significant increase in teams and players from 2021 to 2022. 61.4% (+4.8% on 2021) of games were decided by less than 20 points with an impressive 37.9% (+3.1% on 2021) of games being decided by 10 points or less.

Deloraine Junior Basketball Association

DJBA expressed significant interest in participating in TJBL Northern Conference competition in 2023. BTAS provided DJBA with information about pricing/costs, hosting, travel, and volunteer requirements, and DJBA agreed in principle to

submit a small number of teams into the competition in 2023. This is an exciting step for the competition, as Deloraine represent a midpoint for Launceston travel, and have two quality, compliant basketball courts available for use on Sundays.

Facility Audit Fast fact: 57% of Tasmanian Basketball Clubs, don't have a "home" - ie Clubrooms, bar, canteen, space for social functions.

COMMUNITY & PEOPLE

WNBL Community Engagement

BTAS and the wider Tasmanian Basketball community were fortunate to host two games of WNBL action in Hobart between the Southside Flyers and the Bendigo Spirit. This was a fantastic exercise for raising the profile of women's basketball in Tasmania, with clinics, training sessions, media and fan engagement activities completed throughout the three main regions in between matches fixtured in Hobart. A highlight of this project included the Women in leadership sessions hosted in Hobart with our BTAS program athletes, where they had the chance to hear from Cheryl Chambers, Tracy York, Sara Blicavs and more. This project required significant effort from BTAS to deliver to the community without additional funding.

NWBU Mental Health Round

After being established in 2021, the NWBU Mental Health round was again marked on the NWBU calendar to raise awareness of anxiety and depression in adolescents in our basketball community. This wonderful initiative, led by Josh Salter of Somerset, and supported by BTAS and the NWBU Commission, raised the profile of mental health whilst communicating to members of the public the many avenues to seek support. This year we established the first 'showcase' game on a Saturday evening at Somerset, with a strong 400+ crowd out to support the cause. We thank Somerset Amateur Basketball Association and the Burnie Basketball Association, along with our supporting partner Speak Up, Stay Chatty, for pulling together to establish this event.

General Manager (South) Report



BTAS Southern Commission

Thank you to Andrew Moore (Chair), John McNamara and Craig French who continued to serve in their positions on the Southern Commission. Further development and review of the Commission



charter and operations took place during 2022. The Commission providing a key sounding board for a variety of decisions and strategies.

BTAS - Southern Competitions Committee

Basketball Tasmania's Southern Competitions Committee consisted of Gareth Allen, Kim Upton, Simone Ingham and Nic Martin. We thank these four individuals for their time and expertise in forming the BTSCC for 2021.

PARTICIPATION AND GROWTH

Representative Competitions

Participation numbers in 2022 saw an increase across the board from 1,442 in 2021 to 1,996 registered participants seasons (this includes coaches, team managers and anyone who played multiple divisions), and includes:

- TSBL Men's and Women's Championship and Shield Divisions
- TJBL increase in girls team entered; less team for boys (quality of competition increased)
- U22 Men's and Women's competition



Results - Championship Division

Results - Shield Division


