Chair's Report 2021

To the Tasmanian Basketball Community,

Wow – 12 months is a long time in basketball with a lot occurring on and off the court in our great state in 2021. As the current Chair of the Basketball Tasmania Board I am pleased to provide a report that captures this activity. Of course, as this goes to print – there is also considerable action in 2022, however, for completeness, that is for a subsequent report!

People and Staff

I want to recognise the leadership and governance of the previous BTas Chair, Chris Sommerville who effectively presided over the Board for the majority of 2021, only stepping down in December. Thanks, Chris, for your proactive and inclusive approach, with your expertise and involvement in basketball demonstrated across a number of levels.

On the theme of key contributors to basketball in recent years, in looking back it is very clear that 2021 was a year of some significant movements. In June '21 after 7 years as Basketball Tasmania Head Coach, Mark Radford was successfully appointed as one of the inaugural Assistant Coaches for the JackJumpers, resulting in him moving on from a position which I know Mark was very passionate about. I do want to recognise the positive impact of Mark's leadership and coaching, strongly reflected in the legacy he leaves.

Similarly, and whilst not effected until early in 2022, was the announcement by Basketball Tasmania CEO Chris McCoy (November 2021), that after close to 9 years at the helm, he would step down from the role. There is no doubt that Chris' leadership has been fundamental in a number of basketball achievements being realised across our state – and I know Chris is very proud of the growth of basketball during his time – put quite simply, "He left Tasmanian basketball far healthier than he found it".

A huge thank you to Chris Somerville, Mark Radford and Chris McCoy for their amazing service. Very pleasingly, it was great to announce Nic Martin as the successor for Mark's position - Nic already a recognised, quality coach in our system. A strong recruitment process was also progressed to fill the CEO vacancy for a start date early 2022.

Further changes of staffing for BTas in 2021 included a new GM in the North, with Nathan Anderson successfully appointed (vice Ben Richmond) to work with his counterpart in the South – Gareth Allen.

COVID-19

Whilst 2020 saw us very much reeling from COVID-19; with all sporting communities reacting and responding to something quite unprecedented and for most - unheard of; regrettably 2021 still saw us impacted considerably by the pandemic. Of course, this tested our resolve – changes to guidelines were commonplace, a number of rosters and events cancelled, community basketball and programs impacted, however, I continued to be impressed by the resilience, determination, and perseverance of our people to 'bring back' basketball – whilst ensuring that the safety and health of our community was never in question. As 2021 progressed it was great to see the renewed energy and excitement at being back on court and involved in our wonderful sport – also the healthy numbers participating.

BTas Strategic Snapshot

We continue to be guided by the *Basketball in Tasmania 2019-2023 Strategic Snapshot* and whilst it is acknowledged that during 2021 there have been several disruptions, being true to our BTas vision, mission, culture, strategic pillars, and goal areas is particularly important. The strategic snapshot must function as our blueprint for articulating what success in our sport will look like. Two years in, we need to monitor and track our performance and where necessary, make adjustments to support achievement of outcomes. The Board looks

forward to working collaboratively with our basketball community as part of our shared commitment to growth and continuous improvement.

One area that must be prioritised in Tasmania is **Places to Play**, which is effectively - new and upgraded facilities, with a sense of urgency for more courts growing across our state. Interestingly the call for more facilities is something we share in common with all states and territories – reaffirming the amazing growth and increased interest in basketball right across our country.

I do want to recognise the ongoing commitment of our BTas Head Coaches, network coaches and coaches in our CAMs who collectively drive and support the aspirations associated with **Coaching & Officiating** and **Athlete Development & Pathways** (in our [Strategic Snapshot](#)).

Athlete Development and High-Performance programs continue to deliver, with my congratulations extended to all representative teams that achieved success and to all athletes who have gained selection or recognition for their performance and /or development. *Please refer to the Head Coaches report for further details in this area.* To all associated with our CAMs, who provide opportunities for people of all ages to play and to develop – thank you for your focus on provision at a local level, grassroots engagement and skill development, from beginner to elite.

An area of **Coaching and Officiating** which continues to be a focus for the work of BTas staff, Commissions, CAMs and the Board is – Referees. This is from a number of perspectives. Our approach moving forward will need to be solutions focused, considerate of short and longer term outcomes and encourage innovation. I encourage everyone to lean in together to address this area. A big thank you to all who supported the officiation of our sport in 2021 – referees, scoretable and statisticians.

NBL/NBL1

The 2020 BTas Annual Report provided an indication of Tasmania's excitement at having an NBL team, and of course we all embraced the JackJumpers in 2021, with interest and engagement continuing to build – and their first game getting underway in December '21. Congratulations to all involved with the JackJumpers - what an achievement! BTas must be ready to both harness and take full advantage of the increased interest in basketball that our 'ants' have inspired as they defend our island!

Well done also to NBL1 teams Tornadoes, Chargers and Thunder, however, I expect that 2021 may have left you with some disappointment with the roster being concluded midstream. Great that you have been able to plan with some increased stability for 2022.

Thank you

Whilst the engagement of people and volunteers in sport has become more challenging, we are so fortunate to have such passionate and generous people who contribute in so many ways to our sport. Volunteers continue to be the beating heart of our sport, with significant numbers of people involved in formal governance structures, readily giving of their time. 2021 saw Southern and Northern Commissions operating, the BTas Board convening regularly, CAM presidents meeting (as required), and associations assembling as per their governance arrangements. Pleasing to note the smart use of online technology.

In closing, I would like to recognise the work of all Basketball Tasmania staff and the service and contributions of fellow BTas Board Members. Thank you so much for your time and energy – and your commitment!

Community sport is powered by the tireless work of volunteers across the game, and I pay special thanks and tribute to all involved at associations and affiliates for their passion for the sport and ongoing hard work. Also thanks to the BTAS team who continue to serve the game across a broad range of activity.

Chris McCoy and the team have ensured the game is on a solid financial footing, well placed to build on the interest being generated in the sport highlighted by the JackJumpers entering the NBL in their first season.

As we adjust to "life with COVID", there were quite a few highlights for our sport including:

- Continued growth of our junior development programs from FDP, SDP, Tri-Series competition, and pathway through to representing Tasmania and beyond.
- The inaugural season of the Tasmanian JackJumpers and their arrival in the Tasmanian sporting landscape.
- Announcement of the funding for Indoor Multi Sport Facility at the Derwent Entertainment Centre and new courts at Sorell.
- Basketball Tasmania program athlete Sejr Deans is the first player signed to the Tasmanian JackJumpers.
- Ongoing engagement of commissions in each region to strategically evaluate the best direction for basketball and provide insight to the BTAS Board.
- Continued development of our coaches through the Coach Acceleration Initiative
- Ongoing State Government commitment of \$1M over four years to continue school basketball clinics in conjunction with the NBL1 clubs.
- Development of 3x3 events including Reclink Community Series and 3x3 Hustle.
- Excellent participation numbers across all age groups and competitions including both representative competitions and the Maccas On Your Team holiday camps.
- 12 x Tasmanian athletes with full college scholarships in the USA.

Once again, thank you to all involved in the sport as we strive to be Tasmania's sport of choice.

Basketball Development Manager's Report

2021 was another busy and successful year for basketball in Tasmania. There were a variety of obstacles to overcome throughout the year and while it was at times challenging, the adversity has made our athletes, staff, and families more adaptable and resilient.

The first of these challenges came at the beginning of the year when we were unable to travel to the mainland to participate in any January development tours. Usually we would travel to Albury/Wodonga and participate in the Country Cup which is a beloved tournament for all athletes, staff, and families, but this event was cancelled due to COVID-19. We sought the opportunity to attend a replacement tournament in the Adelaide Invitational Challenge, but again we were unable to attend due to COVID-19.

This was not the only part of the calendar that was impacted by COVID-19. The U20 & Ivor Burge Australian Championships were changed from February in Canberra to May in Mackay, and the U16 Australian Junior Championships were moved from July in Perth to September in Darwin.

Although there were some disruptions, we were fortunate to be able to send our entire cohort of State Teams to all of the 2021 Australian Junior Championships. This is an achievement that not all other State and Territories can boast with New South Wales, Victoria, and the Australian Capital Territory unable to send sides to the 2021 U16 Australian Junior Championships.

We had a mixed bag of results at the 2021 Australian Junior Championships with our U18 Men placing 11th, U18 Women 10th, U20 Men 9th, U16 Women 7th, U20 Women 5th and bronze medals for our Ivor Burge and U16 Men's teams.

It is a phenomenal feat to medal at an Australian Junior Championships and it is needless to say that we are thrilled for our Ivor Burge and U16 Men. From my perspective, the most pleasing part of our entire Nationals campaign was the conduct of all teams and the style in which we played. This is something we pride ourselves on and are nationally recognised for.

On-top of team success, 2021 was a massive year filled with individual athlete success.

- In February, Reyne Smith and Taran Armstrong made their debut for the Australian Boomers in an Asia Cup Qualifier. Both athletes stepped up to the moment and guided the Boomers to a convincing win over rivals New Zealand.
- In April, Launceston local and BTAS High Performance Athlete, Sejr Deans, was the first signing in the history of the Tasmania JackJumpers franchise.
- In June, Rubi Gray received a scholarship to the Centre of Excellence in Canberra following an impressive U18 Nationals. Later that month, Taya Webb, Rubi Gray and Lachlan Brewer were selected to attend the 2021 National Performance Camp. Unfortunately, the camp was cancelled due to COVID-19, but selection for the camp is still a significant achievement for these athletes.
- In July, Taya Webb and Charli Kay were selected as members of the NBA Women's Academy Virtual Program, while Reyne Smith and Taran Armstrong made their return to the international stage, playing for the Australian Emus at the 2021 U19 World Cup.
- 2021 also saw the number of Tasmanian Athletes competing in the U.S College System grow with Aishah Anis, Sharn Hayward, Marshall Evans, Taran Armstrong and Reyne Smith all joining our already strong stocks in the U.S.

From a coach development perspective, 2021 was another strong year in this space. We successfully introduced the Coach Acceleration Initiative which is designed to provide identified coaches throughout Tasmania with additional professional development, training and mentoring opportunities. The one-year program focuses on developing coaches and building depth in the Tasmanian system.

Outside of the Coach Acceleration Initiative, we conducted 28 x Coach Education Activities which included 2 x NBL Coaching Clinics, the annual Gala Weekend clinic, a High-Performance Weekend clinic and several coaching clinics and workshops for our CAMs. There were over 300 participants across the Coach Education Activities.

From a Future Development Program and State Development Program perspective, we have gone from strength-to-strength. We had over 750 athletes' trial for the programs which is the largest number of athletes we have ever had trial for our development programs, close to a 10% increase from 2020. The increase in trial numbers is a reflection of the respect and credibility our programs have, as well as the impact the Tasmania JackJumpers have made in the visibility of the sport.

In the back end of the year, we welcomed two new Basketball Development Officers in James McKinnon and Sam Adams following the departure of Nathan Brereton to the NBA Global Academy and Mark Radford to the Tasmania JackJumpers. Both Sam and James have shown that they are great fits for our state and have helped drive our programs forward.

It would be remiss of me to not thank Mark Radford for all the work he has done for basketball in our State and the work he did to establish and build our programs to what they are today. While there is still work to do, we proudly boast Nationally respected and recognised programs, and this would not be possible without all of Mark's hard work.

To all the network coaches, parents and volunteers who have played a role in developing our State and made 2021 successful, thank you! Your contribution is greatly appreciated.

General Manager (North) Report

Stepping into the General Manager (North) role in September 2021, the immediate challenge was to carry on the great work completed by Ben Richmond in the first half of the 2021 calendar year. The focus was on setting up good governance practices, and engaging members of the community to improve the Basketball experience for all involved – Players, Coaches, Referees, Administrators and Volunteers.

Whilst we have seen some significant change internally, I am optimistic about the opportunities presented to Basketball in Tasmania in 2022 and look forward to working with our Executive Leadership team, the Basketball Tasmania Board, the NWBU Commission, and members of all CAMs, to continue sustainable growth of Basketball in the Northern region.

GOVERNANCE

North West Basketball Union Commission

The NWBU Commission was formed late 2020 to provide governance input whilst representing the former NWBU Inc. Within my first three months of meetings, it was clear to me the commission possessed a wealth of experience and knowledge of basketball on the coast. The NWBU Commission, comprised of Josh Molendyk (Chair), Rebecca Triffett, Darren Long, Sam Armstrong, Shane Hayward, Garry Gale (NW Thunder delegate) and Martin Parker (Referee delegate) continue to provide community feedback, guidance and assistance in all areas of basketball.

Strategically as a group we completed a SWOT analysis of basketball on the North West coast, and are working on a strategic plan, in line with the Basketball Tasmania strategic plan, to ensure sound decisions are made for the sustainable growth of basketball in the region.

Basketball Tasmania Tribunal Panel (North)

There was a concerted effort in the final quarter of 2021 to build an independent Tribunal Panel to be engaged when required. Through our community networks we were able to engage seven tribunal panel members from professional backgrounds including Law, Police, Council, Referee and Government. All members are up to date with the Basketball Australia Tribunal Guidelines and are able to execute a Tribunal hearing as required. We believe this is a great step to ensuring consistent and fair outcomes from any hearing conducted.

PARTICIPATION AND GROWTH

Representative Competitions

The impact of COVID-19 in 2020 saw the NWBU competition severely impacted. Programming resumed in its entirety in 2021 with all scheduled games conducted as planned. The NWBU saw a total of 233 registered players, coaches and team managers across all eight CAMs, participate in 184 games across the regular season and finals. Eventual winners were Ulverstone Redhoppers in the Men and Burnie Tigers in the Women, capping a strong return to operation after the brief hiatus in 2020.

Additionally, in 2021 the TJBL competition was revamped across the Northern region. This involved adjusting the structure of the competition;

- Enabling CAMs to submit multiple teams into each age group
- Increasing competition levels for each age group by configuring Championship division to include 6 teams, and Shield division to be open to any number of teams
- Landmark expansion to include the Launceston Lightning into the TJBL competition

Overall, the participation rates in NWBU, U22s and TJBL competitions totaled 1263 participants, with significant growth in TJBL teams (156% increase from 2020 to 2021) due to the above-mentioned structural changes. This trend has continued across all CAMs in early 2022, indicating the structural changes should lead to a period of sustainable growth.

Results – Championship Division

The margin results experienced in Championship Division throughout the 2021 TJBL Northern Conference Competition were very close and was a good reflection of participants competing against others of similar talent levels. 57.4% of games were decided by less than 20 points, and 35.7% of games being decided by 10 points or less.

Results – Shield Division

The margin results experienced in Shield Divisions throughout the 2021 TJBL Season were also very close given the significant increase in teams and players from 2020 to 2021. 56.6% of games were decided by less than 20 points with an impressive 34.8% of games being decided by 10 points or less.

George Town Basketball Association

An exciting outcome of the continued exposure of Basketball at International, National and State level is the continued interest from all communities. In 2021 we welcomed the formation of the George Town Basketball Association. The George Town community, led by local council and business leaders, engaged interested community members to pull together a working committee, a constitution, and the first official domestic season. The good work of President Brent Daire, local council member Draavid Rao, and the GTBA team saw over 50 juniors play the game of basketball in George Town, when previously they would not have had this opportunity.

COMMUNITY & PEOPLE

NBL Blitz & Community Engagement

As a precursor to the Tasmania Jack Jumpers inaugural NBL season, Tasmania was fortunate to host a considerable number of preseason NBL Blitz games leading into the NBL season tipoff. This proved to be a boon, with a number of school and community-based engagements bringing elite NBL basketballers to grass roots participants. Games were played in Hobart, Launceston and Ulverstone, giving people of all regions in Tasmania the opportunity to access NBL games. Additionally, school-based clinics were conducted in Hobart, Devonport and Launceston, engaging over 250 school kids with the opportunity to meet and greet players from the Perth Wildcats, Adelaide 36ers, Brisbane Bullets and of course, our very own Tasmania Jack Jumpers.

NWBU Mental Health Round

Sadly, the greater community of Somerset suffered the heartfelt loss of the bright Tarkyn Whitehouse. Members of the Somerset Amateur Basketball Association, in conjunction Basketball Tasmania and the NWBU, pulled together to establish a Mental Health Round to raise awareness of mental health amongst young people in our community. This wonderful initiative, was led by Josh Salter of Somerset, and supported by my predecessor Ben Richmond, raised the profile of mental health whilst communicating to members of the public the many avenues to seek support. We thank Somerset Amateur Basketball Association and the Burnie Basketball Association, along with our supporting partner Speak Up, Stay Chatty, for pulling together to establish this event, which will now feature on the NWBU calendar each year.

COACHING AND OFFICIATING

Referee Education

A total of 108 participants completed courses conducted by Basketball Tasmania in 2021.

A breakdown of courses indicates;

- Level 0 Community Course: 7 courses conducted with 100 participants
- Grade 1 Referee Instructor Course: 1 course conducted with 8 participants
- Regions serviced include Hobart, Devonport, Deloraine, Smithton, St Helen's, Launceston.

General Manager (South) Report

GOVERNANCE

Basketball Tasmania Southern Commission

Basketball Tasmania continued to utilise the remarkable strategic abilities of the Southern Regional Commission throughout a turbulent 2021 season. Consisting of Andrew Moore (chairperson), Aaron Pidgeon, Craig French, Michelle Hills and John McNamara, the Southern Commission's composition remained unchanged throughout the duration of the year. Matt Hargreaves and Brett McKay also attended meetings as representatives of NBL1 club Hobart Chargers. These personnel form a strong representation of the Southern basketball community and collectively possess significant sports administration, networking and planning capabilities. The Southern Commission provides an important connection between Basketball Tasmania and its Constituent Association Members (CAM), ensuring that the growth of basketball at the grassroots level is both exceptional and sustainable.

Of particular achievement for the Southern Commission was the introduction of signage displayed across all Basketball Tasmania courts promoting positive and supportive behaviour towards referees and officials. This initiative was instrumental in helping to prevent negative behaviour at Basketball Tasmania competitions and events. This project was completed with resources provided by Play by The Rules and through the support of the Tasmania JackJumpers.

The Southern Commission practices a sincere desire to listen and work collaboratively with others, whilst continuing to prioritise the delivery of strategic outcomes designed to nurture the best interests of basketball in Tasmania. The Southern Commission provides tactical recommendations which are based on evidence and informed by data, whilst simultaneously actioning objectives which align with Basketball Tasmania's Strategic Plan. They value operational transparency and maintain confidential communications with all partners and stakeholders.

The Southern Commission provides support and guidance aligned to the Tasmanian Basketball strategic pillars: Participation and Growth, Places to Play, Athlete Development and Pathway, Coaching and Officiating, Community and People

Basketball Tasmania Southern Competitions Committee

Basketball Tasmania's Southern Competitions Committee consists of Gareth Allen, Kim Upton, Simone Ingham and Nic Martin. This panel possesses a wealth of experience in basketball operations, management, administration and coaching. The Southern Competitions Committee provides effective support to Basketball Tasmania in the pursuit of making strategic and operational decisions regarding the management and coordination of opportunities to play basketball in the Southern region.

The Southern Competitions Committee has displayed an ability to provide unbiased suggestions and impartial recommendations regarding Junior and Senior representative and domestic competitions in the Southern region. The Southern Competitions Committee also provides operational and strategic proposals based on factual evidence and informed discussion which enables Basketball Tasmania to make informed decisions regarding the direction of its competitions.

PARTICIPATION AND GROWTH

The Stars Basketball Club

Assisting with the purchase of balls and general costs, the Glenorchy Basketball Association continued its support of The Stars Basketball Club through 2021. By altering their program to allow the club to participate without providing score bench officials, reducing their cost structure and waiving their administration fees,

Glenorchy has helped to provide an avenue for players with physical and/or mental disabilities to participate in competitive basketball. Glenorchy has also arranged \$2,000 in funding to provide new uniforms for these teams, as well as providing specific referees who have developed and nurtured a positive relationship with these athletes.

Queer Sporting Alliance (QSA)

Participating as members of Glenorchy Basketball Association and competing exclusively out of Moonah Basketball Stadium, Queer Sporting Alliance (QSA) are Australia's largest LGBTIQ+ Sporting club.

By changing the toilet and change room structures at Moonah Basketball Stadium, as well as working with sporting database PlayHQ to update their gender parameters to accommodate for individuals identifying as non-binary, Glenorchy helped to establish a safe and comfortable sporting environment for QSA members.

In collaboration with the Glenorchy City Council, the Glenorchy Basketball Association sponsored the "Come Out and Play" Day to increase the player participation rates within the Queer Sporting Alliance. Glenorchy also maintains significant involvement and support for "Working It Out Tasmania", an initiative which provides support, education and advocacy services for LGBTIQ+ Tasmanians.

As one of the most socially progressive and inclusive sporting clubs in Tasmania, the Glenorchy Basketball Association received the highest sporting award for club culture in Australia and were named the Australian Sports Club of the Year by Good Sports. Selected from a field of over 11,000 clubs with more than 3,000,000 collective members, this is a remarkable achievement.

COMMUNITY & PEOPLE

GBA "Rise Above The Rim" Program

Glenorchy Revellers Basketball club offers a unique opportunity for junior players to become a part of a program that enables them to learn life changing skills, to make new friends, to feel a part of our community and to gain self-confidence. The program also helps players to possess greater team skills, team spirit, team morale, responsibility and work ethic. RATR runs at least 5 events throughout the basketball season, each different but with a focus on leadership and community.

Rise Above The Rim "24-hour Shoot-A-Thon"

Held on Saturday 29th and Sunday 30th May 2021 at Swisherr Academy, Hobart, Rise Above The Rim ran a 24-hour "Shoot-A-Thon" with 100% of the funds raised go directly to Ronald McDonald House Charity. With live music, food trucks and non-stop 24-hour shooting across 9 courts, this event highlighted the close unity amongst the basketball community in the Southern region as over \$65,000 was raised for charity!!

Reclink 3x3 Community Series

On Monday, 6th December 2021, over 100 school students descended on the Swisherr Hoops Academy in Hobart to compete in the 2021 3x3 Reclink Community Series. With 10 schools and 20 teams involved, the 2021 Reclink Community Series saw a tournament-style format with all teams playing each other in one day, culminating with a same-day finals series. Over the course of just 4 hours, 98 games of 3x3 basketball were played in a fast-paced, electrifying format!

Reclink Australia aims to use sport as a vehicle to build social equity and to provide opportunities for individuals from low socio-economic regions. At the conclusion of the event and in collaboration with local Basketball Tasmania Constituent Association Members, Reclink awarded several Basketball Development Scholarships which assists the recipients to continue their participation in basketball.


